**ASSUMPTION OF RISK AND WAIVER OF LIABILITY**

- 1. **ASSUMPTION OF RISK.** The undersigned is aware of the inherent risks of injury, death and property damage to the undersigned or to his or her dog that are involved in the recreational activity of canine sports including without limitation risks due to dog bite, the use of agility equipment or infectious disease. The undersigned is aware of the risks of injury, death and property damage that may result from, among other causes, the active or passive negligence of HAUTE DAWGS AGILITY GROUP and its officers, directors, employees, agents at any location in California (collectively, the "RELEASED PARTIES"), including without limitation the risk of negligent instruction or supervision. The undersigned is voluntarily engaged in dog sports as a recreational activity with knowledge of the risks of injury, death, property damage and other risks, and assumes any and all known and unknown risks of injury, death and property damage that may result from participation in dog sport training, practice and competitive events.
- 2. **RELEASE OF LIABILITY.** The undersigned releases RELEASED PARTIES from all liability to the undersigned and the undersigned's representatives, guardians, successors, assigns, heirs, children, and next of kin for all liability, claims, damage or demands for personal injury, death or property damage, to the undersigned or to the undersigned's dog or dogs arising from or related to this agreement or to participation in dog sport training, practice and competitive events whether the injury, death or property damage occurs on or off any premises. This release includes, without limitation, any personal injury, death or property damage caused by the active or passive negligence of any of the RELEASED PARTIES. The undersigned bears sole responsibility for any loss.
- 3. **KNOWING AND VOLUNTARY EXECUTION.** The undersigned acknowledges that he or she has carefully read this agreement, understands its contents, and understands that this agreement includes an assumption of the risk of the RELEASED PARTIES' negligence and a release of their liability. The undersigned acknowledges that the RELEASED PARTIES are materially relying on this waiver in allowing the undersigned to use the PREMISES to engage in dog sport training, practice and competitive events.
